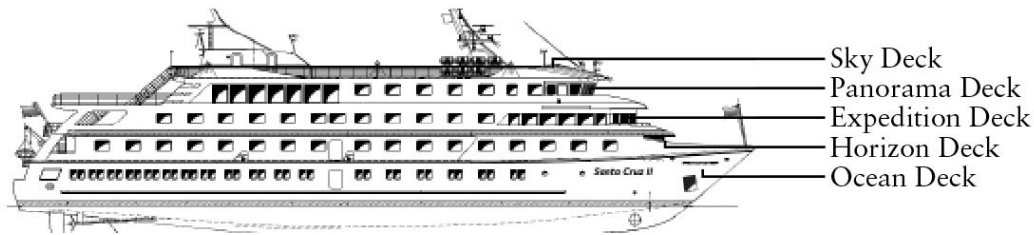




# SANTA CRUZ II AMENITIES

## Currency

The U.S. dollar is the official currency on board the ship. American Express, MasterCard and Visa credit cards are also accepted. Participants may sign for beverages and purchases on board and settle their account prior to disembarkation.

The SANTA CRUZ II has a nonsmoking policy. Smoking is permitted only on the Sky deck in designated areas.

### *Dining*

The SANTA CRUZ II's dining room accommodates all guests at one unassigned, single seating. Menus feature International cuisine. The ship's restaurant staff will do their best to accommodate special dietary requests (i.e. vegetarian, low sodium, etc.). ### *Medical Services*

Shipboard medical services and facilities, including doctor, physician assistant and medications are available for a nominal charge. A first aid kit is available and officers are trained in basic first aid. The ship remains close to shore, and medical services are available in the ports of call.
