



Terms and Conditions

PRICING: Prices are in USD, per person based on double occupancy, subject to availability, and are accurate at time of printing.

COST INCLUDES: Accommodations aboard ship; all meals as indicated in the itinerary; non-alcoholic beverages; beer, wine, cocktails, and spirits, with super premium wines and liquors available for purchase; all shore excursions, sightseeing, special access permits, and entrance fees; transfers to/from airport if traveling on recommended group flights; sauna and fitness room; taxes, service charges; services of Lindblad Expeditions' staff, ship physician and local guides; gratuities to the ship's crew. Unused services or items included in this program are non-refundable.

NOT INCLUDED: Airfare; meals not indicated; extensions; passport and visa fees; travel protection plan; items of a personal nature such as certain super premium brands of alcohol, Wi-Fi, and laundry.

AIRFARE: Airfare is an additional cost. Lindblad Expeditions will gladly assist in making your air arrangements for a \$50 per person service fee.

RESERVATIONS: To confirm your place, an advance payment of 15% of the cabin fare, per person is payable by Visa, MasterCard, American Express, Discover, or check. Receipt of advance payment indicates your acceptance of the terms and conditions.

FINAL PAYMENT: Due no later than 120 days prior to departure. Lindblad Expeditions reserves the right to cancel your reservation if payment has not been received by final payment due date.

TRAVEL PROTECTION PLAN: National Trust Tours strongly recommends the purchase of trip cancellation insurance, which is available for coverage of expenses in conjunction with cancellation due to covered illness or accident. In the event that you must cancel your participation in a travel program, trip cancellation insurance may be the only source of reimbursement. USI Travel Insurance Services offers a plan designed specifically for National Trust Tours travelers, providing coverage for Trip Cancellation, Trip Interruption, Travel Delay, Baggage Delay, Baggage Loss, Emergency Medical and more. Plus, you can upgrade your plan with Cancel For Any Reason (CFAR) coverage for the utmost flexibility. CFAR allows you to cancel your trip for ANY reason at all and be reimbursed up to 70% of your prepaid, non-refundable trip costs (conditions apply, see plan for details). contacting the consulate/embassy of the country(s) you are visiting or transiting through. We will not be responsible if you are denied entry or transit into a country if you are unable to provide valid documents as per the country's requirement.

SMOKING AND VAPING POLICY: Allowed only in designated outdoor areas.

RESPONSIBILITY AND OTHER TERMS & CONDITIONS: Certain other provisions concerning, among other things, limitations of Lindblad Expeditions' and National Geographic Expeditions' (a division of National Geographic Partners, LLC) liability for loss of property, injury, illness, or death during the voyage will be provided to all guests on the ship's ticket sent prior to departure or upon request. By registering for a trip, the guest agrees to all such terms and conditions.

NOTE: Itineraries and prices listed in this brochure are as of publication date and are subject to change. Under normal conditions the total expedition price is guaranteed at the time of booking. However, our expedition pricing is determined far in advance of initial departure on the basis of then-existing projections of fuel and other costs. In the event of increases in those costs, including but not limited to increases in the price of fuel, currency fluctuations, increases in government taxes or levies, or increased security costs, we reserve the right to adjust the price of your expedition or add a surcharge to cover such unexpected increases. We will always provide an explanation of the reason for increase in costs.
