Thompson M. Mayes is Chief Legal Officer and General Counsel for the National Trust for Historic Preservation. As Chief Legal Officer, he oversees the National Trust's legal defense fund, which advocates for the protection of significant places and defends and strengthens historic preservation laws throughout the United States; the historic preservation easements program, which protects

over 135 historic places throughout the country; and the full range of corporate law matters for the National Trust, including specialized areas of historic site management and museum law.

Tom has written and spoken widely on preservation law, the underlying purposes of historic preservation, and the future of preservation. For many years, he taught historic preservation law at the University of Maryland. A lifelong preservationist, Tom serves as a member of his local historic preservation commission in Shepherdstown, WV. A recipient of the National Endowment for the Arts Rome Prize in Historic Preservation in 2013, Tom is the author of *Why Old Places Matter* (Rowman and Littlefield, 2018).

Tuesday, October 6, 2026

HALIFAX, NOVA SCOTIA, CANADA | EMBARK

Arrive at Halifax Stanfield International Airport (YHZ), where you will be met by your driver and transferred to the pier to embark your ship, *L'Austral*. (D)

Wednesday, October 7

AT SEA

Spend a relaxing day at sea enjoying the many comforts aboard *L'Austral*. Attend enriching lectures and briefings, take advantage of the ship's elegant amenities, or simply unwind on deck as you sail the open ocean. Indulge in a treatment at the spa, stay active in the fitness center, or relax in your luxurious stateroom or suite. (B,L,D)

Thursday, October 8

BOSTON, MASSACHUSETTS

Known as "America's Walking City," Boston is the cradle of American independence and one of the country's most walkable destinations. Walk the Freedom Trail to explore Boston's central role in the nation's founding, stroll through elegant Beacon Hill and Quincy Market, or cross the Charles River to Harvard Yard before visiting Copley Square and the Boston Public Library, the first free municipal library in the United States. Friday, October 9

NEWPORT, RHODE ISLAND

Continue to Newport, Rhode Island, a storied seaside retreat of America's Gilded

Age elite. Tour magnificent mansions such as The Breakers and stroll the dramatic Cliff Walk with sweeping ocean views, or sail Narragansett Bay aboard a classic vessel celebrating Newport's legacy as the world capital of sailing, or opt to explore the city's powerful history of enslaved and free Black communities that shaped its past. Saturday, October 10

NEW YORK CITY, NEW YORK

Spend a full day exploring the many layers of America's largest city: walk the Brooklyn Bridge, wander Central Park, explore DUMBO's art-filled streets, reflect at the 9/11 Memorial, or trace immigrant stories at Ellis Island or the Tenement Museum. Monday, October 12

PHILADELPHIA, PENNSYLVANIA



DECK PLAN





Compagnie du PONANT, PONANT Group USA, LLC, and PONANT USA, LLC are hereinafter collectively referred to as "PONANT EXPLORATIONS GROUP" or "PONANT" is the tour Operator/Organizer of this cruise and has invited members of the National Trust Tours (Sponsor) to participate. Please carefully read this information as payment of a deposit represents your acceptance of the following Terms & Conditions, which constitute the sole, legally enforceable agreements between the passenger and PONANT GROUP and the tour's sponsoring organization.

PAYMENT SCHEDULE: To secure a booking, the guest is required to pay a 25% deposit of the tour fare. Final payment is due by July 8, 2026, or 90 days prior to departure. Checks and credit cards are accepted.

CANCELLATION, MODIFICATION PENALTIES & REFUNDS: All cancellations or modifications must be in writing. Any and all guests not reporting for departure or prevented from reporting for departure or waiving for any reason whatsoever the benefit of services included in the program cannot claim any refund. PONANT EXPLORATIONS GROUP shall not be required to refund any monies to any guests who must leave the cruise prematurely for any reason, nor shall PONANT EXPLORATIONS GROUP be held responsible for any costs, fees, damages or causes of action which result from the transportation expenses incurred by guest's early departure. For any deposited or fully paid booking, cancellation penalties will be assessed as noted below. These cancellation penalties are applicable on all services booked with PONANT EXPLORATIONS GROUP.

- From confirmation of booking date up to July 7, 2026, (91 days prior to departure): 10% of deposit to be kept by PONANT
- From July 8, 2026, (90 days prior to departure): 100% of full fare to be kept by PONANT

RATES: The prices given at the time of booking are based on economic conditions known on November 10, 2025, and are subject to change. These conditions are, amongst others, the cost of transport and fuel, relevant dues, and taxes for the proposed operation (port taxes, embarkation and disembarkation taxes, entrance costs to tourist sites), currency exchange rates relevant to the pricing of these programs. PONANT EXPLORATIONS GROUP reserves the right within the legal limits of applicable laws to vary the prices if necessary. All variation of the cost of transport, fuel, taxes, dues, and visa costs will be passed on within the voyage cost. Any change in fare cannot be imposed less than 60 days prior or August 7, 2026, to departure.

TRAVEL INSURANCE: USI Travel Insurance Services offers a plan designed specifically for National Trust Tours travelers, providing coverage for Trip Cancellation, Trip Interruption, Emergency Medical and more. ITINERARY: PONANT EXPLORATIONS GROUP reserves the right to withdraw and/or cancel a sailing to make changes in the itinerary whenever, in its sole judgment, or in the judgment of the vessel owner or operator, conditions warrant it.

INDEPENDENT CONTRACTORS/LIMIT OF LIABILITY: The passenger agrees that PONANT EXPLORATIONS GROUP and National Trust Tours acts as agents and/or trustees for any person, ground and maritime agents and subcontractors, who provide any service forming, or in connection with, any part of the cruise. Transportation services to the port of departure, transfers to the ship, including, as applicable, hotel room and restaurant bookings or guided tours, are performed by independent suppliers who are not employees of PONANT EXPLORATIONS GROUP nor National Trust Tours. In this respect, PONANT EXPLORATIONS GROUP and National Trust Tours acts only as an agent and shall not be held liable for said services or for the acts or omissions of subcontractors or other contractors. PONANT EXPLORATIONS GROUP and National Trust Tours shall not be held liable for bodily injury to, or death of passengers, or for loss of, or damage to luggage or other personal belongings, unless it is proved that the carrier has infringed statutory obligations or that it or one of its employees or agents has committed gross negligence. However, in the event the liability of PONANT EXPLORATIONS GROUP and National Trust Tours is incurred, such liability is limited (details available upon request). PONANT

EXPLORATIONS GROUP and National Trust Tours shall in any case not be liable for failure of an improper performance when the same is due to or caused by the fault of the passenger; the unforeseeable or unavoidable fault of a third party unconnected with the provision of any services to be provided under the contract; unusual and unforeseeable circumstances beyond the control of PONANT EXPLORATIONS GROUP and National Trust Tours; an event of "Force Majeure" such as a war, threat of war, riots, civil commotion, acts of God, terrorist activities, natural and nuclear disaster, fire, technical problems with transport, closure of ports, strikes and any industrial action, or any other event beyond the control of PONANT EXPLORATIONS GROUP or National Trust Tours.

ACCESSIBILITY & MOBILITY REQUIREMENTS: In reserving a PONANT cruise passengers declare they are aware of the physical and medical demands that may be entailed by our excursions, particularly & non-exhaustively, stepping into and out of a tender (assisted by the crew on board) at certain ports of call where we are anchored and not docked in port. Passengers must be fit enough to both physically and psychologically stay for several days at sea in the closed environment of a cruise ship. Passengers must respect the captain's and the crew's orders in case of bad weather or any other incident while at sea or in port.

PERSONS WITH REDUCED MOBILITY: Report any physical conditions and dietary or treatment requirements to the PONANT and National Trust Tours in writing at the time of booking. PONANT will try to accommodate special needs where possible, but any extra costs associated with special accommodation is the responsibility of the passenger. For limited mobility, wheelchair users, or conditions requiring assistance, it is required to inform PONANT and National Trust Tours in writing as soon as possible, but at least within 30 days (September 6, 2026), before the service starts. Despite these arrangements, each passenger should be able to be independent or travel with a close family member or friend who can give them whatever assistance they require during their trip. If a person has not been judged suitably fit for travel in complete safety, the company reserves the right to refuse their embarkation. Disembarkation in difficult places or in a tender is subject to the approval of the captain, who will always have the safety and wellbeing of the passenger in mind. Should a National Trust Tours passenger not be able to participate on the shore excursions, passengers may independently make private touring arrangements at the scheduled ports of call.

ACTIVITY LEVEL DESCRIPTION: This journey features a range of activity levels to suit various preferences and physical capabilities. Most excursions are moderate, typically involving about 1 to 2 miles of walking on a mix of cobblestone, paved, or uneven surfaces, with some stairs or inclines. While some tours are gentle, others are not recommended for guests with limited mobility. These specifications will be shared in an upcoming mailing in the Shore Excursions Descriptions document. In certain ports of call, we will use a tender to disembark and get to shore and then again to embark back onto the ship – this requires stepping down into the tender assisted by your crew onboard.

JURISDICTION: These terms & conditions are subject to and interpreted according to international regulations and concern the transportation of passengers and their luggage from the time of boarding the ship to the moment of disembarking, as well as at ports of departure, destination, or stopover. PONANT EXPLORATIONS GROUP shall incur no liability outside this period. Without prejudice to required legal regulations, any actions related either to the interpretation, or execution of this agreement shall be brought before the competent courts of Marseille-France. PONANT is not responsible for omissions, printing and/or presentation errors and reserves the right to make corrections as required.
