Day 1: Arrive in Phoenix, AZ • Scottsdale

Wednesday, September 15, 2027 (D)

Upon arrival to Phoenix Sky Harbor International Airport an Orbridge representative will be waiting to assist with your transfer to the hotel.

After check-in gather with fellow travel companions for a special welcome dinner.

Overnight: Scottsdale Marriott at McDowell Mountains

Day 2: Scottsdale • Sedona • Grand Canyon National Park

Thursday, September 16, 2027 (B)

After breakfast travel north through the cactus-studded Sonoran Desert arriving at Sedona's stunning Bell Rock Loop. Take advantage of photography opportunities of the magnificent landscape before boarding the motor coach to head into Sedona for lunch on your own.

Sedona is an enchanting Southwestern town with a bohemian vibe. Vast red rock formations provide a serene backdrop for various eclectic boutiques, cafés and art galleries.

Continue to Grand Canyon National Park—a UNESCO World Heritage Site and a natural wonder that showcases the raw beauty of geological forces over millions of years. After checking into the hotel enjoy the remainder of the day for independent park exploration and dinner on your own.

Overnight: Kachina Lodge

Day 3: Grand Canyon National Park

Friday, September 17, 2027 (B)

This morning enjoy time at leisure to explore the park independently or opt for an unforgettable helicopter flightseeing tour over the Grand Canyon's North, South, and East Rims—including the confluence of the Little Colorado River. Soar deep into the canyon for breathtaking views of towering buttes, majestic temples and dramatic side canyons. This extraordinary experience offers a low-impact way to appreciate the grandeur of this natural wonder while remaining mindful of its environmental sensitivity. Aboard a top-tier, eco-friendly EC130 aircraft—featuring forward-facing stadium seating and expansive 180° views—witness the awe-inspiring eastern gorge, the forested North Rim and the striking Dragon Corridor. *(This optional excursion can be purchased in advance from our Guest Services team. Space is limited. We recommend reserving early for best availability.)*

Afterward gather with the group for optional guided Grand Canyon touring to Mather Point and the Visitor Center.

Mather Point is a popular and easily accessible viewpoint on the South Rim. This location offers stunning panoramic views and showcases the canyon's incredible depth and scale.

Guests may wish to enjoy a picnic lunch and leisure time at Grandview, a favored spot for anyone seeking a bit of solitude amid the grandeur of the Grand Canyon. This was once the site of the Grandview Hotel, a popular destination in the late 19th century that quickly fell into disuse with few traces remaining today. Alternatively return to the lodge and enjoy the on-site dining options.

The remainder of the day and evening are open for various activities. Take a guided program that explains the geologic and human history of the canyon or walk the rim at sunset. Other options include strolling the Trail of Time, learning about the history and formation of the Grand Canyon at the Yavapai Museum of Geology, and/or visiting the historic Kolb Studio to learn about the art of the Grand Canyon.

Overnight: Kachina Lodge

Day 4: Grand Canyon National Park • Page • Lake Powell

Saturday, September 18, 2027 (B,D)

Departing the Grand Canyon stop at Desert View to see the iconic Watchtower and nearby trading post.

Continuing to Page, lunch is on your own followed by guided touring at Antelope Canyon.

Antelope Canyon's narrow passages and distinctive swirling rock formations are the result of water erosion and wind over thousands of years. The mesmerizing interplay of light against the rock formations makes this site a haven for photographers—shifting colors and textures create a dynamic visual experience unseen anywhere else.

This evening gather together for a relaxing dinner and time to unwind at the property.

Overnight: Lake Powell Resort

Day 5: Lake Powell • Bryce Canyon National Park, UT

Sunday, September 19, 2027 (B,L,D)

After breakfast set out on an exciting adventure in Glen Canyon—a rafting float trip down the calm waters of the Colorado River.

As you drift along the river admire various geological features including ancient petroglyphs, rock formations and the unique striations in the canyon walls. This float trip also provides excellent wildlife spotting opportunities—keep an eye peeled for eagles and California Condors.

Arriving to Lees Ferry there will be time for a picnic lunch before departing for Bryce Canyon.

This evening settle into your accommodations then rejoin the group for dinner.

Overnight: The Lodge at Bryce Canyon

Day 6: Bryce Canyon National Park • Zion National Park

Monday, September 20, 2027 (B)

Today experience Bryce Canyon, a surreal and captivating landscape of intricately carved hoodoos, towering spires and vibrant rock formations. One of the must-visit viewpoints within the park is Bryce Point where the magic of Bryce Canyon truly unfolds.

Bryce Point's expansive panorama offers uninterrupted views of Bryce Amphitheater, a vast bowl-shaped area filled with a labyrinth of massive hoodoos.

Continue on to Sunset and Sunrise Points, each displaying striking geological structures carved over millions of years.

This afternoon following leisure time for lunch depart for Zion National Park.

Overnight: Zion Park Lodge

Day 7: Zion National Park

Tuesday, September 21, 2027 (B,D)

After breakfast board an open-air tram for a leisurely ride to see and learn about some of the most treasured spots in Zion Canyon. Your expert guide will offer local knowledge and deep insight about the park.

The remainder of the day is open for independent touring of Zion National Park where your activity options are plentiful. Perhaps hike to the Emerald Pools, stroll along the Riverside Walk or take a ranger-led program. Visit the Human History Museum, which provides insights into the indigenous peoples, early pioneers and the park's natural history through exhibits and interactive displays.

Tonight gather with fellow travel companions for dinner.

Overnight: Zion Park Lodge

Day 8: Zion National Park • Las Vegas, NV

Wednesday, September 22, 2027 (B,R)

Venture into Zion for a final morning of exploration.

This afternoon depart for Las Vegas with time to refresh before a special farewell reception to celebrate your memorable time discovering America's Southwest.

The evening is at leisure to stroll The Strip or to take advantage of the amenities and dining options at the hotel.

Overnight: The Westin Las Vegas Hotel & Spa

Day 9: Depart Las Vegas

Thursday, September 23, 2027 (B)

After breakfast guests departing during the suggested times take a complimentary transfer to Harry Reid International Airport for flights home (or to Salt Lake City for guests joining the optional post-tour).

Activity Level: 3

Moderate

Tour days tend to be long, flow at a consistent pace and may include long periods of travel. Guests should be prepared to walk longer distances, climb stairs and tolerate periods of standing, for example on city walks, sightseeing stops or excursions, on

sometimes uneven surfaces including cobblestones or unpaved pathways and trails. Some destinations may have variations in altitude and/or temperature. Daily pace and timing may vary significantly between longer and shorter travel days, with additional activities possibly occurring in the early morning or evening. Guests are expected to board transportation without assistance. Elevators are not always available at accommodations or sites visited.

- Many of the parks have dirt trails but they are usually smooth for walking. Some have paved pathways and boardwalks.
- Altitudes vary—rising up to 9,000 feet above sea level.
- Guests should be able to embark and disembark a scenic raft, have a proper fit into a life jacket, and remain seated and balanced in the craft.

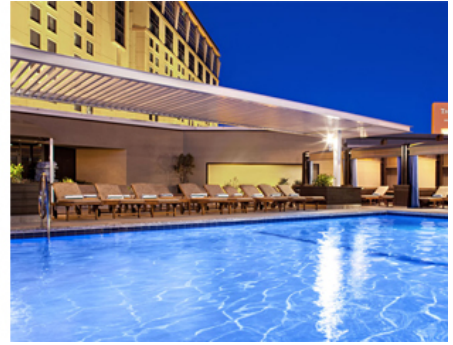

SALT LAKE CITY TO DENVER ABOARD CANYON SPIRIT



Travel by luxury train from Salt Lake City through the red rock formations of Moab in America's Southwest to the mile-high city of Denver. Oversized windows and glass-domed coaches allow you to relax and soak in the magnificent scenery that includes colorful deserts, natural archways and bewitching hoodoos. As the *Canyon Spirit* train winds past ancient rock canyons, through mountain ranges and alongside rivers, watch for wildlife like bighorn sheep, bears, mountain lions, deer and marmots. Entertaining stories from onboard hosts and comfortable travel combine with locally inspired cuisine to make this an unforgettable adventure. Off the train, enjoy nature with guided tours of Canyonlands National Park and Arches National Park.

Itinerary

Canyon Spirit operates on tracks owned by freight companies, like other passenger railways in North America. Day 9: Depart Las Vegas • Arrive in Salt Lake City, UT

Thursday, September 23, 2027

Upon arrival to Salt Lake City International Airport transfer to the hotel.

The remainder of the day is at leisure to explore independently.

Overnight: The Grand America Hotel

Day 10: Salt Lake City • Canyon Spirit • Moab • Canyonlands National Park

Friday, September 24, 2027 (B,L)

This morning board the *Canyon Spirit* to travel by rail to Moab through awe-inspiring and colorful landscapes featuring astounding rock formations.

Savor a two-course hot breakfast while watching the morning light bounce off magnificent Parachute Creek and Mount Logan. Admire the red rock formations in Ruby Canyon and look for Mount Garfield. At 6,600 feet, it's the highest point of the Book Cliffs and easy to spot.

As the train approaches Moab notice the brilliant red sandstone backdrop and get an initial glimpse of iconic Arches National Park—a 73,234-acre wonderland of geological marvels. Depart the train and transfer to downtown Moab.

This afternoon visit Canyonlands National Park for guided sightseeing. Canyonlands' diverse landscape promises spectacular views of towering rock pinnacles and striking desert vistas. Over time the Colorado River and its tributaries have carved intricate buttes and river beds into this beautifully rugged terrain.

Later transfer to the property for an evening at leisure.

Overnight: Moab Lodging

Day 11: Arches National Park • Canyon Spirit • Glenwood Springs, CO

Saturday, September 25, 2027 (B,L,D)

Following breakfast set out for Arches National Park—featuring more than 2,000 natural sandstone arches. Observe the myriad of unusual rock formations, including Balanced Rock and the world famous Delicate Arch. See arch formations that include cliff-wall arches, free-standing arches, pothole arches and natural bridges. In addition there are 745 species of flora in Arches National Park. Hundreds of types of grasses, cacti, evergreens, deciduous trees, flowers and bushes have adapted to surviving in the harsh conditions.

Return to the *Canyon Spirit* to travel the rail route to Glenwood Springs. Celebrate crossing the Continental Divide with a sparkling wine toast. Later hear engaging stories of the region from on-board hosts and delight in a three-course lunch. Admire the scenery along the Colorado River through picturesque Byers Canyon and Gore Canyon.

Disembark in Glenwood Spring—a resort city beside the rugged Rocky Mountains. Surrounded by the vast White River National Forest, the area is well-known for its hot springs and outdoor adventures. Within the town's vibrant history, John Henry "Doc" Holliday traveled here in the late 1800s seeking a cure for his advanced tuberculosis. A museum bearing the name of this dentist-turned-gambler/gunfighter exists in the heart of downtown. Glenwood Springs also has a dynamic dining and entertainment scene.

This evening enjoy time to explore independently.

Overnight: Glenwood Springs Lodging

Day 12: Glenwood Springs • Canyon Spirit • Denver

Sunday, September 26, 2027 (B,L)

Embark upon the *Canyon Spirit* one more time for the final and most dramatic leg of your rail journey to Denver.

Departing from Glenwood Springs, the train begins its eastward ascent into Colorado's Rocky Mountains—a realm of towering peaks, deep canyons and spellbinding beauty. Watch as the train hugs the banks of the Colorado River, winding through rugged red rock canyons and tunnels carved into the mountainsides. Glide past whitewater rapids, pine-covered slopes and the iconic rock formations of Glenwood Canyon.

Cross the Continental Divide via the historic Moffat Tunnel—an engineering marvel over six miles long—before emerging into the breathtaking vistas of the Front Range.

As you approach Denver reflect on the unforgettable journey through one of North America's most magnificent rail corridors—an inspiring finale to cap off this adventure.

After breakfast guests departing during the suggested times take the complimentary transfer to the airport for flights home.

All such persons and entities are independent contractors. Reservations, Deposits and Final Payment. Reservation Changes. Reservation changes (including, but not limited to, name changes) are subject to availability and cannot be guaranteed. Reservation changes will not incur an administration fee except in the following cases: 1) Reservation changes completed 90 or fewer days from the tour's scheduled departure date for all tours except Antarctica Discovery, African Expedition by Private Train and all 2026 Total Solar Eclipse Tours will incur a \$150 administrative fee plus any third-party penalties and/or charges. 2) Reservation changes completed 195 or fewer days from the tour's scheduled departure date for Antarctica Discovery, African Expedition by Private Train and all 2026 Total Solar Eclipse Tours will incur a \$150 administrative fee plus any third-party penalties and/or charges. In addition, any reservation changed from double occupancy to single occupancy will be charged the single occupancy rate, which will be due at the time of final payment or upon receipt of an updated invoice if received after the tour's final payment due date.

Reservation Cancellation and Refunds. Notice of cancellation must be submitted to Orbridge in writing either via email or mailed letter. The date of receipt will be used for the effective date and the cancellation will be processed as follows:

(a) For all tours except those noted in (b) and (c), if the cancellation notice is received by Orbridge more than 90 days prior to the tour's scheduled departure date, all monies paid to Orbridge for the main tour and for any pre-tour and/or post-tour will be refunded less an administrative fee of \$350 per person for the main tour and \$200 per person for a pre-tour and/or post-tour. If the cancellation notice is received by Orbridge between 90 and 76 days prior to the scheduled departure date, a 25% cancellation fee will be applied to the full cost of the tour, including any pre-tour and/or post-tour, optional excursion(s) fees and optional electives, and the balance will be refunded. If the cancellation notice is received by Orbridge between 75 and 61 days prior to the scheduled departure date, a 50% cancellation fee will be applied to the full cost of the tour, including any pre-tour and/or post-tour, optional excursion(s) fees and optional electives, and the balance will be refunded. If the cancellation notice is received by Orbridge between 60 and 46 days prior to the scheduled departure date, a 75% cancellation fee will be applied to the full cost of the tour, including any pre-tour and/or post-tour, optional excursion(s) fees and optional electives, and the balance will be refunded. If the cancellation notice is received by Orbridge within 45 days prior to the scheduled departure date, a 100% cancellation fee will be applied to the full cost of the tour, including any pre-tour and/or post-tour, optional excursion(s) fees and optional electives.

(b) For Antarctica Discovery, African Expedition by Private Train and 2026 Iceland and the Cosmos: A Total Solar Eclipse at Sea, if the cancellation notice is received by Orbridge more than 195 days prior to the scheduled departure date, all monies paid to Orbridge for the main tour and for any pre-tour and/or post-tour will be refunded less an administrative fee of \$950 per person for the main tour and \$200 per person for a pre-tour and/or post-tour. For Castile and the Cosmos: Total Solar Eclipse in the Heart of Spain and Catalonia and the Cosmos: Total Solar Eclipse on the Spanish Coast, if the cancellation notice is received by Orbridge more than 195 days prior to the scheduled departure date, all monies paid to Orbridge for the main tour and for any pre-tour and/or post-tour will be refunded less an administrative fee of \$350 per person for the main tour and \$200 per person for a pre-tour and/or post-tour. If the cancellation notice for Antarctica Discovery, African Expedition by Private Train and all 2026 Total Solar Eclipse Tours is received by Orbridge between 195 and 150 days prior to the scheduled departure date, a 25% cancellation fee will be applied to the full cost of the tour, including any pre-tour and/or post-tour, optional excursion(s) fees and optional electives, and the balance will be refunded. If the cancellation notice is received by Orbridge between 149 and 120 days prior to the scheduled departure date, a 50% cancellation fee will be applied to the full cost of the tour, including any pre-tour and/or post-tour, optional excursion(s) fees and optional electives, and the balance will be refunded. If the cancellation notice is received by Orbridge within 119 days prior to the scheduled departure date, a 100% cancellation fee will be applied to the full cost of the tour, including any pre-tour and/or post-tour, optional excursion(s) fees and optional electives.

(c) All payments made for Tanzania Wildlife Safari's Rwanda pre-tour are non-refundable.

A 100% cancellation fee applies to all non-refundable airfare. Refunds, if any, will be processed within 30 days of our receipt of your written notice.

Travel Insurance. Orbridge strongly recommends that you purchase travel and cancellation insurance to protect your investment in the event of unexpected or unforeseen circumstances. In addition, we recommend that you consider obtaining a policy(ies) that will cover emergency medical evacuation insurance and cancel for any reason insurance. Travel and cancellation insurance policies and dates by which policies must be purchased vary by provider/insurer, maximum coverage (including cancel for any reason) is generally only available for purchase within 14 days of your reservation being confirmed. It is advised to determine your insurance needs and make necessary arrangements soon after reserving on tour. If you do not have, but are interested in purchasing, travel and cancellation insurance please contact us.

Tour Cancellations or Postponements. All tours are subject to cancellation or postponement by Orbridge prior to the scheduled departure date for reasons such as, but not limited to, insufficient participation, or logistical problems that, in Orbridge's sole judgment, may impede tour operations or represent conditions or events that may expose tour guests and/or Orbridge to undue risk of harm, injury, damage or inconvenience. In the event of tour cancellation or postponement by Orbridge, Orbridge may offer you alternative arrangements such as the option to join the same tour on a different date or a different tour. If the price of your alternative booking is lower than your original booking price, Orbridge will refund the difference within 30 days of the alternative tour's departure date. If it is higher than your original booking price, Orbridge will invoice you the difference and you will be responsible therefor. Transferred guests are subject to the terms of the original tour. Except for force majeure, if a tour is cancelled or postponed by Orbridge, Orbridge will refund all payments made within 30 days of notice of tour cancellation or postponement if an alternative arrangement is not offered.

Itineraries. Accommodations, ship type, train type, the itinerary, travel directors or expedition leaders, lecturers, hosts, faculty or organization representative, and arranged excursions are subject to change or substitution at any time due to unforeseen circumstances or circumstances beyond Orbridge's control. Reasonable efforts will be made to operate tours as planned, however adjustments, substitutions and changes may occur after the final itinerary has been issued. Orbridge may, in its sole discretion, withdraw a tour or any part of it, make such alterations or substitutions to the itinerary or tour inclusions as it deems necessary or desirable, and pass on to tour participants any expenditures or additional costs caused by any such adjustments, or by delays or events beyond its reasonable control.

Not Included. Unless otherwise specifically noted in the itinerary, tour prices do not include the following expenses, which if applicable are your sole responsibility to pay and satisfy: trip cancellation insurance and passenger travel protection plan; domestic, international, and internal airfares except as indicated in tour inclusions; transfers and luggage handling fees except in connection with scheduled group flights; costs associated with obtaining passports or entry visas; airport departure taxes; airline ticketing fees; airport transfers when arriving/departing on other than scheduled group dates; excess baggage charges; any new value added taxes or other taxes added to tour costs by applicable governmental authorities; gratuities to drivers, guides, or ship's crew not specified; meals and beverages other than those specified as being included in the itinerary; sightseeing not included in the itinerary; personal expenses such as laundry, communication charges and optional activities (which are subject to availability); ship, air, or transportation fuel surcharges, if applicable; any items not on the "included" list of the tour documents.

Health and Fitness to Travel. Through your participation in your tour, you assume responsibility for your own health, safety, and welfare and acknowledge that Orbridge cannot absolutely guarantee your safety or health. Your physician can provide guidance on your personal health risk and precautions to take while traveling. Some tours include physically active elements. To enjoy these tours as intended, a minimum level of fitness is required and Orbridge will require all guests to follow local, state, national and/or World Health Organization health and safety mandates. Accordingly, you must be in good physical and mental condition to participate. You represent that you have no physical, mental or other condition, impairment or disability that may or will cause or create a risk of injury or other hazard to yourself or others in respect to any aspect of the tour you have selected. Orbridge may, in its sole discretion, limit, restrict or prohibit from participation in any aspect of any tour any individual that it considers in its sole discretion to be impaired or unsuitable due to fitness level. In addition, Orbridge may, in its sole discretion and at the participant's sole expense, remove the guest from the tour, or restrict the tour-related activities of any individual whose physical or mental condition may or is likely to cause a hazard to himself/herself or others, or otherwise impair the enjoyment of other tour participants. Any physical condition requiring special attention, diet, or treatment must be reported in writing to Orbridge at the time a tour reservation is made. Should you have any questions or need any clarification about a specific tour, please ask for details at the time of registration. Orbridge will try to accommodate your situation if possible.

Tour participants must be mentally and physically fit for travel, as determined by Orbridge, along with our Travel Directors. Orbridge reserves the right to remove any individual whose condition or behavior—including but not limited to abusive, threatening, or offensive conduct, harassment, possession of illegal items, or any actions that compromise the

operation of the tour or the safety or enjoyment of others—is deemed inappropriate. In such cases, tour participants removed from a tour for failure to adhere to this policy are responsible for all costs related to their removal. No refunds or reimbursement will be provided for unused portions of the tour or any additional expenses incurred.

Accessibility. Orbridge cannot guarantee that the transportation, lodging, and entertainment/sightseeing accommodations will be accessible to all persons regardless of their physical and mental condition. In addition, many of the activities involved in each tour include walking or the like for some distance on uneven ground or pavement or moving water as well as the ability to walk up and down stairs without assistance. Should any individuals seeking to participate in a travel opportunity need special accommodations to ensure their enjoyment of the trip, kindly provide notice at the time the reservation is submitted, and we will see if your participation is feasible. Please understand that the Americans with Disabilities Act is inapplicable outside the United States.

Because this is a group travel tour with shared transportation, accommodations, and excursions, there may be limitations that affect our ability to safely and comfortably accommodate a service animal on a particular itinerary. We will review the details with guests on a case-by-case basis to determine whether a tour is able to accommodate a service animal. We do not permit pets on tour.

At the time of reservation, Orbridge needs to be notified to determine if the special needs of an individual traveler can be met through special arrangements. It is possible that minor modifications to the services can be provided, but only if Orbridge is made specifically aware of anticipated needs. This notification should be made in writing no less than two weeks prior to the planned travel. Neither Orbridge nor any of the providers of transportation, lodging, or other services can provide special accommodations without this advance notice.

Where an individual with certain specific needs will be traveling with a group, it is necessary for other members of that person's group to be available to assist as necessary. Neither employees of Orbridge nor any suppliers of services can allow any of their employees to provide physical assistance to any guests.

Travel Advisories. The State Department and the Centers for Disease Control periodically issue statements and advisories about risks to travelers. These statements are country specific and contain important information. The State Department information can be found at www.travel.state.gov, and the CDC statements can be found at www.cdc.gov. Orbridge highly recommends everyone to review these sites.

Children. Orbridge welcomes the participation of children in most of its tours. However, in the event you do include your children or other minors for whom you serve as legal guardian ("Dependents") in your travel plans, you hereby agree that you are and shall be at all times solely responsible for their care, actions, safety and protection during the tour and any pre-tour and/or post-tour. Should you have any questions whether a particular tour or inclusion is possible or suitable for your Dependent(s), please contact us.

Adults who are not the parent or legal guardian of a minor traveling with them must present an original, notarized letter signed by the child's parent(s) or legal guardians authorizing the adult to take the child on the specific cruise, supervise the child, and allow emergency medical treatment to be administered, if needed. This is necessary even when the adult traveling is part of the child's extended family (including but not limited to aunts, uncles, and grandparents). Registered Guests. For the comfort and safety of all travelers, participation in any and all portions of an Orbridge program, including transportation, accommodations, excursions, and meals, is limited exclusively to registered guests, unless expressly authorized in writing by Orbridge prior to departure.

Pets/Animals. Orbridge does not permit pets on tour. Please see "Accessibility" regarding service animals.

Baggage. Tour rates include the price of one piece of policy-compliant baggage per person during the land, cruise or rail portion of the tour only unless specified in the itinerary. Air carriers and motor coaches often impose significant other restrictions or limitations on the number of pieces, size and weight of luggage and may reject or impose additional fees on luggage exceeding such limitations or restrictions. All such fees are your sole cost and responsibility. In addition and regardless of location or transportation method, your baggage and personal effects are and shall at all times be at your sole risk throughout the entire tour. Please check with your air carrier for other applicable baggage restrictions and limitations.

Travel Documents. All guests are responsible for possessing and maintaining necessary travel documents. These documents shall be valid under state and federal law and as required by foreign countries being visited. Orbridge is not responsible for invalid travel documents and repercussions thereof.

For U.S. citizens, valid passports are required for travel to foreign destinations and some countries require specific visas prior to entry. Please direct any questions in respect to visa requirements to Orbridge, which shall use commercially reasonable efforts to provide answers as a courtesy, provided that it shall remain your sole responsibility and obligation to obtain and verify that you have all required travel documents, including visas, necessary and appropriate for the tour location(s) and sufficient blank pages in your passport for visas and immigration stamps. In addition, some countries require your passport to have an expiry date of not less than six months after your anticipated return to the United States. Orbridge disclaims all liability for any expenses or costs you may incur due to your prohibition or restriction from entering a country on the tour itinerary or reentering the United States at the conclusion of the tour. If travel documents fail to meet these requirements, boarding of aircraft or ship to any international destination may be denied and entry into such countries may be denied.

Photos and Videos. Orbridge may take photographs and/or video of its trips and participant grants Orbridge permission to do so and for it to use such for promotional or commercial use without payment of any compensation to participant. In addition, Orbridge may use, without compensation, any photographs or video taken by tour participants and submitted to Orbridge or to SmugMug without payment of any compensation. In submitting any such photographs or videos to Orbridge or SmugMug, participant warrants that he or she took the image and that the dissemination of same does not violate the copyright rights of any person.

Data Rights, Permissions. Data collected and/or derived by Orbridge resulting from your use of the Website is the sole and exclusive property of Orbridge and may be used in any manner consistent with its Privacy Policy located on Orbridge's website. By submitting to Orbridge a digital or hard copy form that includes your personal contact information, including without limitation, your email address and telephone number(s), you give Orbridge and any other entity identified on the form permission to use that information to contact you and as otherwise may be described on the form and/or in the Privacy Policy.

Other. Dates, tour details and costs are based on tariffs, exchange rates and other information current at the time of printing, but are subject to change at any time. While we do not anticipate material revisions of the itinerary or its included features, we do reserve the right to substitute accommodations or modes of transportation and to make any changes in the itinerary Orbridge, in its sole discretion, deems necessary and in that case any additional expense or cost will be paid by the individual guest. Your baggage and personal effects are your sole responsibility at all times. It is prohibited by federal law and Orbridge policy to bring illegal drugs, firearms, or other contraband (including marijuana for medical or recreational purposes) on any tour.

Orbridge may at any time and without notice modify these terms and conditions, and any modification so made will be effective for all reservations made from and after the posted Effective Date.

In the event any term in these terms and conditions is deemed unenforceable the unenforceable clause shall be interpreted to give effect to the parties' intentions to the greatest enforceable extent, and all other provisions hereof shall remain fully enforceable according to their terms.

Individual Supplier Contracts. Individual contracts/terms from Orbridge's contracted suppliers govern the relationship between that supplier and the Orbridge guest. These respective contracts/terms often establish limits on liability, limits on claims, define the time to file claims, the acceptable jurisdictions for making claims, etc. They should be reviewed with care.

The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable. By agreeing to these terms and conditions, both parties are waiving their right to a trial by jury. Any arbitration commenced against Orbridge must be on behalf of only the individual(s) to this Agreement and his or her immediate family members traveling with them, such as a spouse or child. Under no circumstances can participant be part of a class or other joint action.
